A law (No. 248, H 580) enacted by the Legislature of Alabama Regular Session 1945, approved by the Governor on July 6, 1945, and amended by Act No. 97, 1956; Act No. 476, 1957; Act No. 591, 1967; and Act No. 684 of the 1977 Legislature, provides that the occupant of a position in the Classified Service of one of the above municipalities shall be elected each year to serve as a member of the Citizens Supervisory Commission. Said member is to be elected by the Classified Employees of all the above municipalities. The one-year term will commence on November 1, 2025 and end on October 31, 2026. There are two meetings a year, the third Tuesday in November and May, at noon, and special meetings as scheduled.
